

# Concert In The Country: Food Truck Vendor Agreement

## BENEFITTING BOOTS FOR TROOPS

SATURDAY, OCTOBER 21<sup>ST</sup>, 2023

The Concert In The Country is a eight annual event that is held at a private farm in Magnolia, Texas. **This is a rain or shine event.** There will be no refunds due to inclement weather. All food truck vendor spaces are outside spaces.

1. The Event committee will evaluate each food truck's qualifications and reserves the right to deny space or individual items in a space that are not of the highest quality. Any vendor found in violation of the following rules may be removed from the event facility.
2. To be complete, this application must be filled out in its entirety and be accompanied by:
  - Payment of the deposit or full payment. Payment is accepted in the form of cash, check or money order. (Food truck vendors not accepted will receive a full refund of the truck space fee.)
  - Copy of GL Insurance to operate.
  - At least 2 photos showing a menu and examples of items to be sold.
3. Deadline for receipt of all completed applications is Friday, **OCTOBER 4<sup>th</sup>, 2023**. (Vendors will be reviewed on an as received basis.)
4. Food truck vendors are required to provide their own generator for their electricity needs.
5. Food truck vendors must provide their own table(s) for condiments, utensils, and all food service needs. We encourage our food truck vendors to set up and use background materials (if preferred) at designated assigned spots. However, please be mind-full of your neighbor, create an attractive display.
6. Food Truck vendors are required to have a health permit to operate in Montgomery County, TX.
7. Food truck vendor hours:
  - *Date* – October 21<sup>st</sup>, 2023
  - *Service to the public:* - 1:30 pm—11:00 pm
8. Food truck vendor set up and tear down:
  - Vendor must arrive by 12:00 pm on October 21<sup>st</sup>, 2023 and be set up by 1:30pm.
  - Vendor must remove all cars immediately from the concert area after unloading and prior to setting up. All vehicles must be clear of the concert area by 12:30 pm.
  - Any vendor who does not arrive by 12:00pm, will risk the possibility of losing their food truck space with NO REFUNDS.
  - BFT maintains a high standard when it comes to SAFETY for all involved in the concert and our community. BFT takes safety very seriously and it is our first priority.
  - **FOOD TRUCK VENDORS MUST BE PRESENT AND SET UP DURING ALL HOURS OPEN TO THE PUBLIC.**

- Food truck vendor may not start to tear down or load up until 11:00 pm. Vehicles will not be allowed in the concert area until all attendees have left the facility.

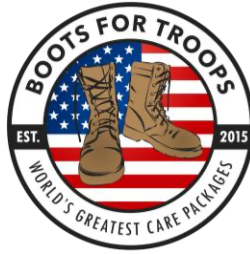

11. Food truck vendor is required to turn in a gross sales receipt to BFT at the close of the event.
